
When the Second Chance Accommodation Program began in 2012, the HLTTV supported nine patients/families with two apartments at a cost of \$11,238. Some nine years later in 2020-21, we supported 38 regional and interstate families in eight local apartments.

Despite the challenges we have faced because of COVID-19, our SCAP program has provided significant support to transplant recipients through 2,328 nights of accommodation.

With our total financial support running to over \$70,000 each year, HLTTV volunteers and our generous supporters have worked hard to ensure financial assistance is available for transplant recipients and their families, particularly rural, regional and interstate families receiving their second chance at life through heart or lung transplantation.



## The objects in the HLTTV Constitution of the Association are as follows:

## INCREASE PUBLIC AWARENESS OF THE NEED FOR ORGAN DONATION

There are nearly two thousand Australians currently on waiting lists and sadly some patients will die before a suitable organ becomes available. Members of the Association actively promote organ donation. The most crucial aim of the Association is to increase the number of registrations on the Australian Organ Donor Register.

## PROMOTE THE RECOGNITION AND ACKNOWLEDGMENT OF THE DONOR AND DONOR FAMILY

Those patients who are alive today because they received a transplant, hope that donor families feel a sense of comfort in knowing that because of their decision to donate, someone will live and other families will be saved the pain of a loved one's death. The Association supports the Annual Thanksgiving Service and also encourages its members to participate to remember and acknowledge the many people who have given the "Gift of Life".

## RAISE FUNDS AND ACCEPT DONATIONS AS APPROPRIATE FOR THE TRANSPLANT CLINIC AT THE ALFRED

Many of the members joined the Association to give something back through supporting fellow patients and the Alfred. Money received through generous donations, or raised from raffles and other fund raising activities, is used to purchase medical equipment, fund transplant related research or anything else that can assist the Alfred's transplant unit or associated wards.

### COMMUNICATE TO MEMBERS AND OTHER INTERESTED PARTIES THROUGH A PERIODIC NEWSLETTER

Keep membership informed as to what the Association is doing through the periodic newsletter, *The Circulator* as well as through our website and email broadcasts.



PROVIDE GENERAL ASSISTANCE (INCLUDING ACCOMMODATION, EQUIPMENT AND RELATED SERVICES OR FINANCIAL ASSISTANCE WITH ANY SUCH MATTERS) PEER SUPPORT AND ENCOURAGEMENT FOR ALL "PRE" AND "POST" HEART AND LUNG TRANSPLANT PATIENTS, THEIR FAMILIES AND/OR THEIR CARERS

The need for peer support provided the impetus to form the Family Fund, the forerunner to the Association. The time waiting for a transplant or recovering from a recent transplant operation can be stressful for patients, their families or their carers. It is well known that people with good peer support do better both mentally and physically. The support provided by others who have had the same or similar experiences can help through difficult times. The Association also provides other services to patients e.g. fitness grants and the Accommodation Program to assist their well being and those of their families and/ or carers.

## PROVIDE RELEVANT INFORMATION AND ENCOURAGE HEALTHY LIFESTYLE CHOICES TO ENSURE THE MAINTENANCE OF OPTIMAL PHYSICAL HEALTH

Being as well as possible before transplant will make it easier for the patient and transplanted organ to stay healthy after transplant. Good nutrition and healthy living are important both before and after transplant.

## INFORM THE PUBLIC ABOUT THE PREVENTION OF DISEASES THAT MAY RESULT IN ORGAN TRANSPLANTATION

Being conscientious to small details without becoming obsessive, such as hygiene, having the annual flu vaccination and being consistent with taking medications is important. However it is still necessary to reinforce the message as often as possible to enhance patient outcomes.

## ENGENDER FRATERNAL FEELINGS AMONGST "PRE" AND "POST" HEART AND LUNG TRANSPLANT PATIENTS AND THEIR FAMILIES THROUGH SOCIAL ACTIVITIES

The Christmas and Easter BBQs have always been well attended and provide a great chance to meet other members. Other social events will be held from time to time.

In particular the Association has links with the *Heart to Heart House* in Barmah (which provides respite for transplant patients) and is also a signatory to the *DonateLife* Communications Framework and accordingly a *DonateLife* Partner.

The Association, through its *Second Chance Accommodation Program,* seeks to ease this burden on the patients and their families and/or carers by providing subsidized accommodation through serviced apartments. While we may not have had our Easter BBQ or Spring Gala, and our committee meetings have all been on Zoom, HLTTV has still had an incredibly active year supporting those on the heart and lung transplant journey.

We have of course continued our wonderful partnership with the Park Regis. Our flagship *Second Chance Accommodation Program* has maintained funding for eight dedicated rooms for transplant recipients and carers from throughout Victoria, South Australia, Queensland and regional New South Wales. The challenges of lockdowns and travel restrictions between states, and between metropolitan and regional areas have meant many on the transplant journey have faced more time away from home than ever before.

Maarit, Martina, Petra and Sam have continued to deliver the all-important post-transplant education sessions virtually. HLTTV members have also provided significant peer support over the phone, and through our emergency financial assistance grants.

In the spirit of relentless optimism, I'll finish by pointing out that we did in fact have more than 300 days OUT of lockdown, and with strong vaccination rates across all of Australia I think I'll say once again – to better days ahead, and to seeing you all safe, well and in real life sometime soon.

## **NOTES TO THE FINANCIAL STATEMENTS** FOR THE FINANCIAL YEAR ENDED 30 JUNE 2021

#### a) Basis of Preparation

The Officers of the Association have prepared the financial report on the basis that the Association is a non-reporting entity because there are no users dependent on general purpose financial report. This financial report is therefore a special purpose financial report that has been prepared in accordance with the requirements of the Constitution and the Australian Charities and Not-for-profits Commission Act 2012.

These financial statements are presented in Australian dollars (\$).

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

#### b) Income Tax

The Association is exempt from income tax pursuant to the Income Tax Assessment Act 1997.

#### c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables in the assets and liabilities statements are shown inclusive of GST.

#### d) Cash & Cash Equivalents

Cash and cash equivalents in the statement of financial position comprise cash at bank and in hand and short-term deposits with an original maturity of three months or less where the investment is convertible to known amounts of cash and is subject to insignificant risk of changes in value.

#### e) Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the entity and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

A review of financial statements in accordance with ASRE 2415 is a limited assurance engagement. The assurance practitioner performs procedures, primarily consisting of making enquiries of management and others within the entity, as appropriate, applying analytical and other review procedures, and evaluating the evidence obtained.

A review is substantially less in scope than an audit conducted in accordance with Australian Auditing Standards, and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

#### Independence

In conducting our review, we have complied with the independence requirements of the Australian Charities and Not-for-profits Commission Act 2012.

Based on our review, which is not an audit, we have not become aware of any matter that makes us believe that the financial report of Heart and Lung Transplant Trust (Victoria) Incorporated does not present fairly, in all material respects, in accordance with the Australian Charities and Not-for-profits Commission Act 2012, including:

- giving a true and fair view of the registered entity's financial position as at 30 June 2021 and of its
  performance for the period ended on that date; and
- complying with accounting policies prescribed in Note 1of the financial report.
